# About the Pennsylvania Pharmacists Care Network



PPCN is the 4th largest affiliate of the CPESN, America's first clinically integrated network of pharmacy provider.



# About the Pennsylvania Pharmacists Association




# Education & Meetings

PPA's Annual Conference brings together pharmacists, pharmacy technicians, and student pharmacists from across the Commonwealth and surrounding areas. Attendees represent all practice areas: independent, chain & hospital pharmacy, ambulatory care, managed care, long-term care, pharma, academia, wholesalers, government, insurers and pharmacy benefit managers. In addition to innovative education, the conference features dedicated exhibit hours with an accompanying virtual exhibit through the conference app, fundraising, networking and social events, and additional sponsorship opportunities to participating exhibitors.

PPA hosts two regional symposiums where we take our proven networking opportunities to our members where they live and work.
